Sub: Compliance by Akums Drugs and Pharmaceuticals Limited (the “Company”) in relation to the press release number 283/2015 dated November 30, 2015, the circular no. CIR/CFD/DIL3/18/2015 dated December 31, 2015, as amended by the circular no. CFD/DIL3/CIR/P/2016/53 dated May 3, 2016 (collectively, the “SEBI Circulars”) issued by the Securities and Exchange Board of India (“SEBI”)

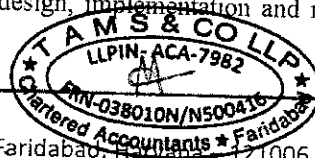
1. This report is issued in accordance with the terms of our engagement letter dated November 16, 2023.
2. We, T A M S & CO LLP, chartered accountants with firm registration number 038010N/N500416 and peer review certificate number 014962 valid till February 02, 2026, have been requested by the Company to verify and certify whether the exit offer price (“Exit Price”) calculated by the management of Akums Drugs and Pharmaceuticals Limited (hereinafter referred as “Company”) in **Annexure C** (hereinafter referred as Statement) with respect to a preferential allotment of 1,005,000 and 120,000 equity shares to 64 and 11 persons (the “Original Allottees”) on December 13, 2004 and March 31, 2005, respectively, i.e., a total of 1,125,000 Equity Shares at a price of ₹ 20 (face value of ₹ 10 with a premium of ₹10) per equity share (such equity shares, the “Allotted Shares” and such allotment, the “Stated Allotment”), details of which have been included as **Annexure A** (hereinafter referred as Statement), is in accordance with the SEBI Circulars. The Original Allottees have, over the course of time, transferred the Allotted Shares held by them (such transfer, the “Stated Transfers”), the details of which are enclosed as **Annexure A** (hereinafter referred as Statement).

The SEBI Circulars stipulate that the option for refund shall be provided to the current holder of securities in case of transfer by the original allottees. Since the Company has not been able to trace the relevant documentation with respect to some of the Stated Transfers, as a matter of abundant caution and in good faith, the exit offer has been provided to all existing shareholders of the Company as on November 15, 2023 (the “Eligible Equity Shareholders”) at an offer price of ₹76.89 per equity share. The details of the Eligible Equity Shareholders and number of shares held by them is enclosed as **Annexure B** (hereinafter referred as Statement).

Pursuant to the SEBI Circulars, in respect of cases prior to April 1, 2014 involving issuance of securities to more than 49 persons but up to 200 persons in a financial year, a company may avoid penal action if it provides its current shareholders (i.e., the original allottees, if such persons continue to hold such securities as on date, or the persons holding such securities as on date pursuant to transfers from the original allottees, as applicable) with an option to surrender the securities and obtain the refund amount/exit price at a price not less than the amount of subscription money paid by the original allottees, along with interest at the rate of 15% per annum thereon or such higher return as promised to investors subject to adjustment of amounts already paid to the holders of such securities either as interest or dividend or otherwise.

Management’s Responsibility for the Statements

3. The preparation of the Statements is the responsibility of the management of the Company including the preparation and maintenance of all accounting and other relevant supporting records and documents. This responsibility includes the design, implementation and maintenance of internal control relevant to the

Practitioner's Responsibility

5. Pursuant to the requirements of the SEBI Circulars, it is our responsibility to obtain reasonable assurance and form an opinion as to whether the Annexure A (Statements), Annexure B (Statements), and Annexure C (Statements) are in agreement with the audited financial statements for the year ended March 31, 2005, books and records of the Company.
6. The financial statements referred to in paragraph 5 above, have been audited by another firm on which they have issued an unmodified audit opinion vide our reports dated June 24, 2005.
7. We conducted our examination of the Annexure A (Statements), Annexure B (Statements), and Annexure C (Statements) in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by the Institute of Chartered Accountants of India. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the Institute of Chartered Accountants of India.
8. We have complied with the relevant applicable requirements of the Standard on Quality Control (SQC) 1, Quality Control for Firms that Perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Services Engagements.
9. We have obtained and verified the following documents and explanations from the Company ("Reviewed Documents"):
 - (i) Form 2 filed by the Company with the Registrar of Companies for the Stated Allotment, which includes the consideration for such issuances;
 - (ii) Relevant minutes of the meetings of the board of directors of the Company for the Stated Allotment.
 - (iii) Relevant documents such as transfer forms/ transfer deeds, to the extent available in the Company's records and noting of the board of directors of the Company in respect of the Stated Transfers.
 - (iv) Verified the arithmetical accuracy of the Exit Price calculations made by the management of the Company as per **Annexure C (Statements)**.

Opinion

10. Based on our review of the Reviewed Documents and verification of the Exit Price as calculated by the management of the Company as per **Annexure C (Statements)** per equity share, we confirm that the Exit Price calculated is in accordance with SEBI Circulars. For the purposes of calculation of the Exit Price, the original allotment price of ₹ 20 per equity share has been considered and a simple interest rate of 15% per annum (as required by the SEBI Circulars) has been applied from the date of the Stated Allotment till November 30, 2023. Further, as informed and confirmed by the company, no dividend pay-outs or interest or dividend or otherwise has been paid to the investors from the date of allotment till November 30, 2023.

Restriction on Use

11. This report is addressed to and provided to the board of directors of the Company solely for the purpose of certifying the compliance of the requirements as per the SEBI Circulars in relation to the option given to Eligible Equity Shareholders of the Company to surrender/ sell/ transfer the securities and get the refund amount/ exit price in accordance with the SEBI Circulars. Accordingly, we do not accept or assume any liability or any duty of care for any other purpose or to any other person to whom this report is shown or into whose hands it may come without our prior consent in writing for any other purpose.



12. We hereby consent that this certificate may be delivered to any governmental or regulatory authority including the SEBI, stock exchanges, the Registrar of Companies, Delhi and Haryana at New Delhi and may also be delivered to the book running lead managers to the proposed initial public offering of the Company and their respective legal counsel or any other advisors of the Company, as may be required and may be referred to in any document issued by or on behalf of Company, including the offer documents in relation to the proposed initial public offering of the Company.
